To consider obtaining a new electricity supply contract.

NB: This report deals with the office costs only.

Background

Our current fixed contract with SSE expires on Oct 31st 2025 and without a new contract or moving suppliers, we will be supplied at variable business rates.

Therefore, moving across to variable rates will equate to an annual increase of £862.02 (40%).

Utility Broker Quotations

Several brokers have been approached for indicative new contract pricing, however, the quotes below are based on live pricing and as a result change on an almost daily basis.

Therefore, it is likely that by the time Council resolves to accept a particular quote then it may already be out of date.

New supply rate quotations (EDF Energy via Utility Aid) show a £556.57/ year saving on current rates for both 1 & 2 year fixed terms and £546.00/year saving over a 3 year fixed term.

Duration of contract

The key decision for Council is the length of contract to undertake to balance the certainty of budgeting against the potential price decrease or increase over the medium term in the face of geopolitical risks, global trade pressures and any volatility that lies ahead.

Officer's Recommendation

That once the desired contract period is decided, Council delegates the decision to the proper officer in consultation with the Chair of the Council to select the cheapest quote available from one of the following established providers using the services of a utility broker such as 'Utility Aid', or 'Cardinal Energy' to obtain best quotes and to enter into a contract accordingly:

SSE; EDF; E.ON; Scottish Power; Npower; British gas (Centrica).

(These companies being considered 'the big 6' providers and so presumably from a business continuity perspective more able to withstand the volatility that has seen smaller providers become insolvent recently).

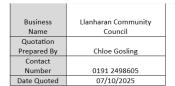

As I previously mentioned, the energy suppliers are currently forecasting that wholesale prices are going to reduce each summer moving forward. With this in mind, we are only really offering 1 and 2 year contracts to avoid our clients agreeing long contracts should prices reduce as forecast.

I have attached todays market forecasts from Total Energies, Crown Gas & Power and SSE. The tables below taken from these reports show where they are each forecasting wholesale prices of electricity (E/MWh) at different touch points moving forward.

FOD Price

You will notice that all three suppliers are forecasting wholesale prices in summer 2026 to be around £74/MWh and then around £69/MWh in summer 2027, both of which are lower than the current level of £82/MWh. The 1-year contracts are currently the cheapest as there is less risk for the suppliers as they can pass on any increases onto you in 12 months when the contract expires. The 2 year plan gives you more protection should any geopolitical tensions escalate and cause energy prices to rise. No matter what you do with this supply you are going to see a decent reduction in costs.
