Whilst it can be demonstrated that efforts have been made to obtain further quotations for the work, In order to proceed on the basis that only 1 quotation has been received for each element of the work as shown in the tables above it will be necessary to suspend financial regulation 11.3e)ii). 





Public Consultation - Llanharan Community Council

Specifics of the Community Council's 'Ewenny Bridge' project

Llanharan Community Council intends to use its CIL¹ funds to design and commission a new bridge over the River Ewenny to be built in Brynna Woods, to replace the existing narrow pedestrian bridge.

The Council has currently earmarked £275,000 of CIL funds for the entire project.

The project also includes a new pathway between the Network Rail Trenos railway crossing bridge (at the time of writing the railway bridge is under construction) and the planned new Ewenny River bridge.

The planned bridge deck is likely to be approximately 20 metres long and 3 metres wide and will sit along a similar route to the current narrow pedestrian bridge.

In common with the Network Rail Trenos railway crossing bridge, both the new river Ewenny bridge and the connecting pathway will be designed to be suitable for use by all users including pedestrians, cyclists, horse riders, disabled people and those with impaired mobility therefore being fully compliant with the Equality Act 2010 and family friendly.


Context

For many years a Community Council working group comprising Community Councillors, The Wildlife Trust of South and West Wales, RCTCBC, Network Rail, Persimmon Homes, the British Horse Society and other stakeholders has been working to develop a wider scheme with the aim of providing a safe multi-user² route from the south of the railway line near Trenos, over the railway and river Ewenny and through Brynna Woods connecting the communities of Llanharan and Brynna via the woods.


Network Rail have already commenced construction of the Trenos Railway crossing bridge.

Llanharan Community Council's 'Ewenny Bridge' project currently comprising the new River Ewenny Bridge and connecting pathway forms part of this overall scheme.

Once a suitable network is built and in place, Network Rail intend to apply to create a formal Bridleway along this route, this aspect of the wider project does not form part of this current public consultation.

The project aspires to make improvements to the surfaces of paths to the south and north of both bridges through Brynna Woods nature reserve in order to make them suitable for all users, including disabled people and those with impaired mobility, however this aspect of the project does not form part of this current public consultation.

Specific points of note for the Community Council's Ewenny Bridge project.

- The Community Council 'Ewenny Bridge project to which this public consultation applies, solely comprises the construction of a new bridge over the River Ewenny and the pathway to connect that bridge to the Network Rail railway crossing bridge currently under construction.
- 2. The Community Council will obtain best value at all stages of the project by entering into competitive tendering processes where relevant in line with the relevant Public Procurement Regulations and Acts.
- 3. The Community Council will engage suitably qualified and experienced people and companies to deliver the project on its behalf.
- 4. The Community Council working group has over a number of years engaged with Natural Resources Wales, Network Rail, Persimmon Homes, Dwr Cymru Welsh Water, RCTCBC Rights of Way and Structures and other groups in anticipation of formal applications for the relevant licenses and permissions required for the project.
- 5. All aspects of the project and any work will be carried out in consultation and full agreement of the Wildlife Trust of South and West Wales who own and operate the Brynna Woods nature reserve.
- 6. The project would proceed on the basis that RCTCBC would 'adopt' the Ewenny river bridge and take on future inspection and maintenance, subject to technical approvals and the relevant formal processes.

- 7. All aspects of the design and commissioning of the project funded by Llanharan Community Council would be funded exclusively via the Council's CIL funds and not via precept funds raised via council tax receipts.
- 8. The Council may consult the public again in future regarding the specifics of any design, construction methods or other aspects of the project.
- 9. Subject to any future application by Network Rail to create a Bridleway along the route, a separate statutory consultation exercise would be carried out in the usual way by RCTCBC.

This aspect of the wider project does not form part of this current public consultation.
