	b. Meadow Rise - To report that Llanmoor Homes confirmed the small piece of flat land between houses has nothing underneath it. In response the Acting Clerk wrote to the Director at Llanmoor in November 2019, to request permission to plant trees on this land – no response has been received.
	The Meadow Rise sites will be added to the maintenance team monthly schedule following the employment of a new staff member.

7	<b>RIGHTS OF WAY (ROW) a. RCT, Network Rail and Persimmon Homes</b> – To report the meeting is scheduled for 11 <sup>th</sup> February,1pm, Llanharan OAP Hall.
	b. Llanharan 5 walking route - The work scheduled for Autumn 2019 was delayed due to bad weather and poor ground conditions. The RCT Rights of Way Senior Ranger will re-survey Llanharan to finalise which stiles need to be repaired or replaced with gates and to liaise with land-owners as necessary.
	i. <b>Recommended -</b> The Committee agree for LCC maintenance staff to assist the ROW team with Llanharan 5 walking route and where appropriate undertake training on how to fix/fit gates and stiles.
