ADVICE TO COUNCILLORS:

The law, and the Council's Code of Conduct, require you to declare personal interests. Some personal interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.

(There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this).

This form enables you to record those interests, or to show that you have no such interests to declare.

Please remember that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at each and every meeting. This is your personal responsibility.

You may also need to declare the interest as a prejudicial interest.

This is very important— please consult the Code of Conduct for the rules on this and / or speak to your Clerk.

BOX B – INTERESTS BEING DECLARED

1. Details of any employment or business carried on by you.

2. Details of any person who employs or has appointed you, any firm in which you are a partner or any company for which you are a remunerated director.

5. Details of any contract for goods, services or works made between your authority and you or a firm in which you are a partner, a company of which you are a remunerated director, or a body of the description specified in (4) above.

6. Details of any land in which you have a beneficial interest and which is in the area of your authority.

9. Details of any —

- (a) public authority or body exercising functions of a public nature;
- (b) company, industrial and provident society, charity, or body directed to charitable purposes;
- (c) body whose principal purposes include the influence of public opinion or policy;
- (d) trade union or professional association; or
- (e) private club, society or association operating within your authority's area, in which you have membership or hold a position of general control or management.
