You may also need to declare the interest as a prejudicial interest.

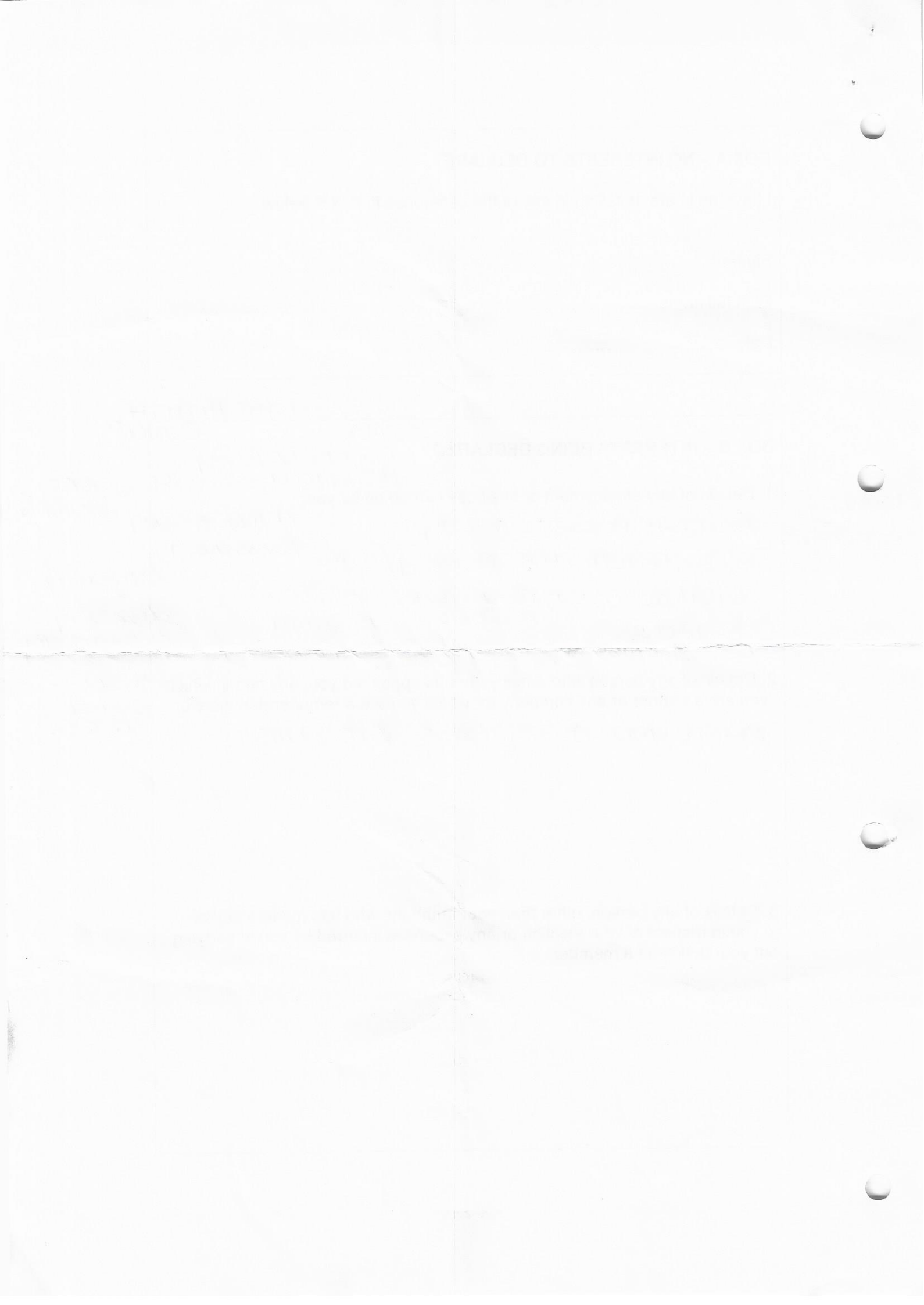

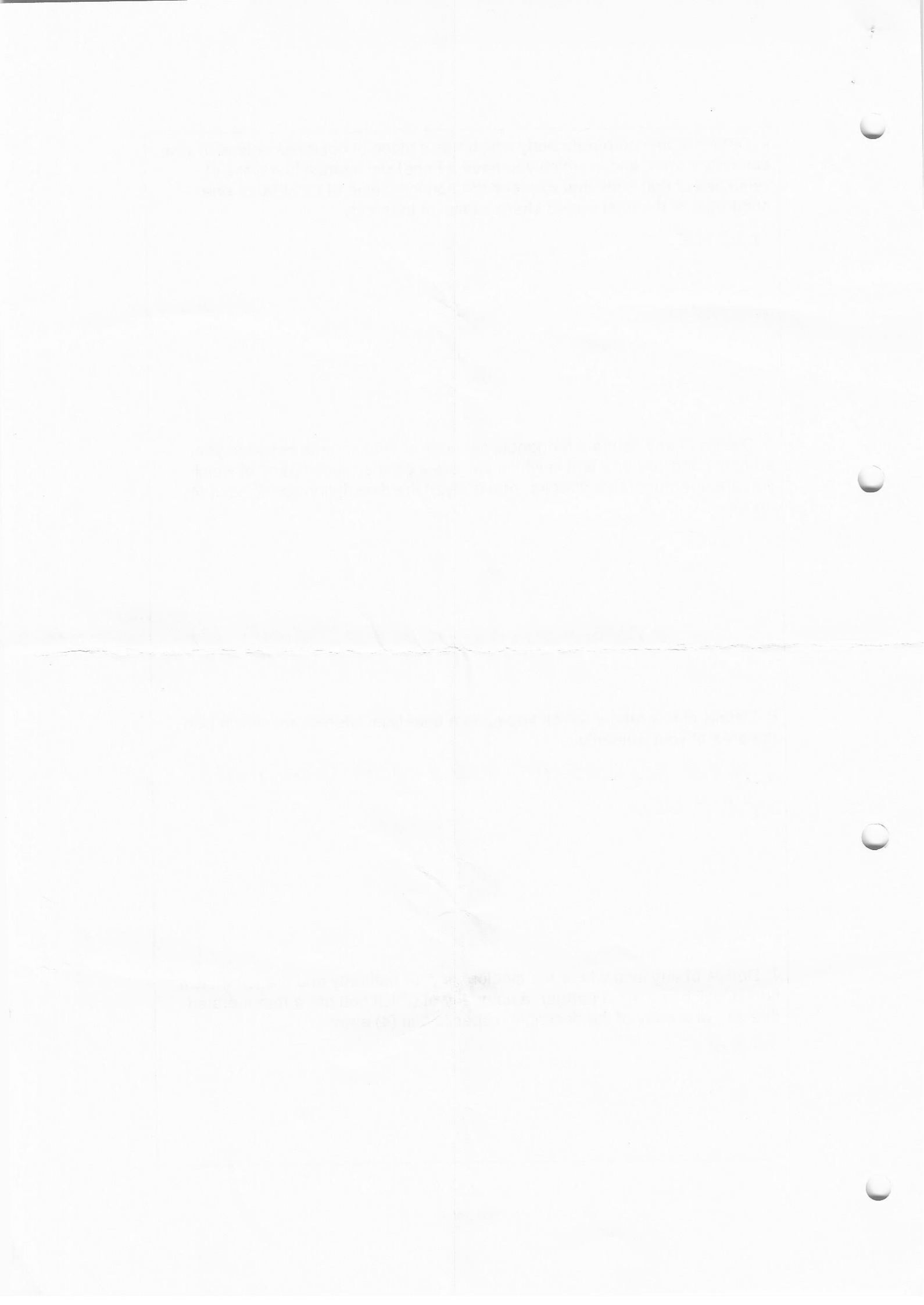

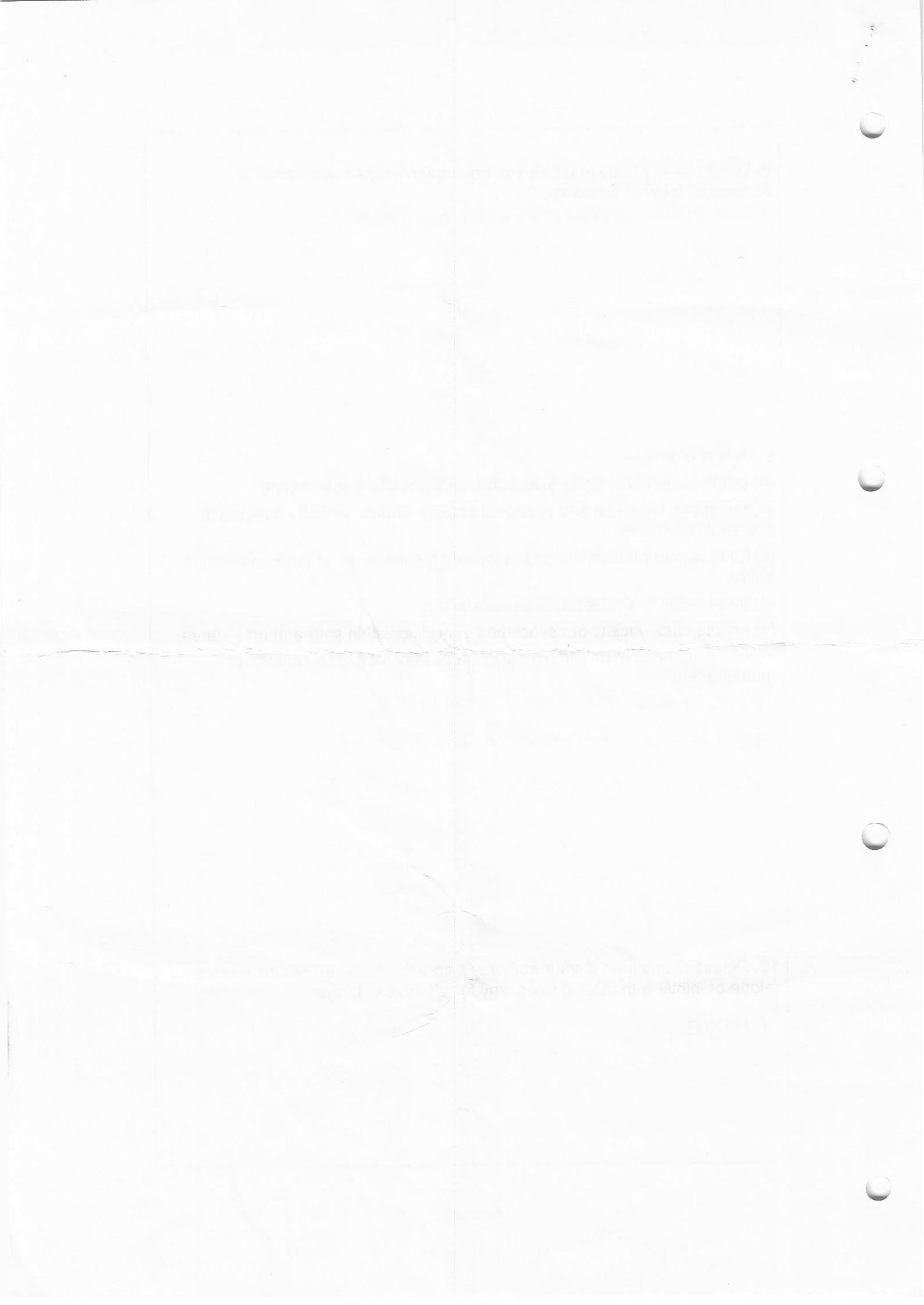
