Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Llanharan Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

Clerk's salary

The Clerk's contract of employment sets out the Clerk's salary as being within band LC2. I was not fully able to reconcile the actual gross salary paid to the Clerk for the year. Based on the salary point paid at the year end, the Clerk appears to have been underpaid.

We recommend that the Council reviews the Clerk's pay to ensure the correct payment is made as per the contract of employment.

Precept

The Council has statutory power to raise a precept which must equal its calculated budget requirement. The Council must make a resolution to set the precept.

We noted that the Council does not record the amount of precept it is to raise. Instead it simply refers to a Band D council tax equivalent.

To ensure transparency, we recommend that the Council specifies the total value of the precept to be raised.
